RESOLUTION NO. 265.

A RESOLUTION CREATING AN EMERGENCY BUDGET PURSUANT TO REVISED CODES OF MONTANA, 1947, SECTION 11-1409 FOR THE WATER DEPARTMENT CALLING FOR THE TRANSFER OF ~~MONIES~~ MONEYS FROM THE GENERAL FUND TO THE MAINTENANCE AND OPERATION FUND OF THE WATER DEPARTMENT. AND PROVIDING FOR NOTICE OF PUBLIC HEARING.

WHEREAS, A public emergency exists which could not reasonably have been foreseen at the time the City budget for the City of Polson, Montana, and,

WHEREAS, The maintenance and operation department of the water fund is insufficient for current needs and thus a public emergency exists, and

WHEREAS, It is estimated that Four Thousand and no/100 Dollars (\$4,000.00) will be required to meet the emergency existing in the maintenance and operation department of the water fund, and;

WHEREAS, The fund against which emergency warrents shall be drawn is the general fund of the City of Polson, Montana, and;

WHEREAS, A public hearing will be held on the creation of said emergency budget on Monday, April 15, 1968. at the hour of 8:00 at the City Hall of the City of Polson, Montana, Notice of said hearing to be ~~publi~~ published in the Flathead Courier on Thursday, April 4, 1968.

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Montana:

That a public emergency exists in that there are insufficient funds for the operation of the maintenance and operation department of the Water Department of the City of Polson, Montana, and it is necessary ~~x~~ to create an emergency budget in the amount of ~~Four~~ Four Thousand and no/100 Dollars (\$4,000.00) for the continuing operation of said department during the budget year 1968. said emergency warrents to be drawn against the general fund of the City of Polson, Montana.

Be it further resolved that a public hearing will be held on the question of creating the said emergency budget at 8:00 P.M. on April 15, 1968, at the City Hall of the City of Polson, Montana. Be it further resolved that a copy of this Resolution be published in the Flathead Courier on the 4th day of April, 1968.
