## RESOLUTION NO. 268.

Approximately two (2) acres, more or \*\* less, of lot Six (6)

Section Four (4), Township Twenty--two (22) North, Range twenty (20) West,

M.P.M. more particularly described as follows:

Beginning at a point 140 feet west of the Southwest corner of Lot Six (6), Section Four (4), Township Twenty-two (22) North, Range Twenty (20) West, M.P.M. thence west 132 feet; thence a due northerly direction 390.6 feet; thence North 69\* a distance of 291.4 feet; thence in a due southerly direction 395 feet; thence in a due Westerly direction 140 feet; thence South 100 feet; to the point of beginning, and; commencing at the Southwest corner of Lot Six (6), in section Four (4), Township Twenty-two (22) North, of Range Twenty (20) West; Montana Meridian; thence running West 140 feet; thence running North 100 feet; thence running East 140 feet; thence running South 100 feet to the point of beginning.
