

RESOLUTION NO. 272.

A RESOLUTION DETERMINING THE AMOUNT OF THE CITY TAXES FOR ALL PURPOSES, TO BE LEVIED AND ASSESSED ON THE TAXABLE PROPERTY IN THE CITY OF POLSON, MONTANA, FOR THE CURRENT FISCAL YEAR.

WHEREAS, the revised codes of Montana, 1947, Section 84-4729 enjoins upon the City Council the obligation to fix and determine the amount of the City taxes to be levied and assessed upon the taxable property within the City, for the current fiscal year, and;

WHEREAS, said resolution must be passed on or before the second monday in August of each year, and immediately thereafter the City Clerk must deliver a certified copy of the same to the County Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, that the taxes for all purposes, to be levied, and assessed on the taxable property in the City of Polson, Montana, for the current fiscal year shall be, and the same hereby are, fixed and determined in accordance with schedule "A", attached hereto, and by the reference made a part hereof as though set forth ~~fully~~ fully at this place.

BE IT FURTHER RESOLVED, that the City Clerk forthwith, and not later than the 12th day of August, 1968, deliver a certified copy of this resolution to the County Clerk of Lake County, Montana.

RESOLUTION NO. 273.

A RESOLUTION PROPOSING TO EXTEND THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THAT CERTAIN TRACT OR PARCEL OF LAND HEREINAFTER DESCRIBED WHICH IS CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Polson, at a regular meeting held on the 5th day of August, 1968, at the City Hall in the City of Polson, Montana, duly considered the question of extending the boundaries of the City of Polson to include the contiguous tract of land hereinafter described, and

WHEREAS, it appearing to the City Council of the City of Polson, Montana, that the following tract of land is contiguous to the City of Polson, Montana, to-wit:

A portion of the West 273 feet of the South 1187 feet of the SE $\frac{1}{4}$ NW $\frac{1}{4}$ , Section 9, Township 22 North, Range 20 West, M.P.M. County of Lake, Montana, and more particularly described as follows:

Beginning at a point 1047 feet west of the Southeast corner of Lewis Addition to the City of Polson, Lake County, Montana, on the South line of "K" Street, thence South 504 feet; thence West 200 feet, thence North 172 feet; thence East 180 feet; thence North 332 feet; thence east 20 feet to the point of beginning, 0.94 plus or minus acres;

and in the judgment of the City Council of the City of Polson, Montana, it will be to the best interests of the said City and the inhabitants thereof, and the inhabitants of the hereinbefore described contiguous tract, that the boundaries of the City of Polson, Montana, shall be extended so as to include the hereinbefore described contiguous tract of land within the corporate limits thereof;

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Polson, Montana, that it is their intention to extend the boundaries of the City of Polson, Lake County, Montana, so as to include the above described contiguous tract of land within the corporate limits ~~thereof~~ thereof; and

BE IT FURTHER RESOLVED that in the judgment of the City Council of the City of Polson, Lake County, Montana, it will be to the best interests of the City and inhabitants thereof, and in the interests of the inhabitants of the hereinbefore contiguous tract, that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the City of Polson, Montana.

BE IT FURTHER RESOLVED that the City Clerk of the City of Polson, Montana, forthwith notify in writing ~~in~~ the property holders within the boundaries of the hereinbefore described tract of land, and

cause to be published in the Flathead Courier, a newspaper published in the City of Polson once a week for two (2) successive weeks, a notice of passage of this Resolution, which notice shall further state that for a period of twenty (20) days after publication thereof, the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the City of Polson, Montana, as in this Resolution provided from the free holders of the territory herein proposed to be embraced in the corporate limits of the City of Polson, Montana.

The foregoing Resolution was duly and regularly passed by the City Council of the City of Polson, Montana, and adopted and approved by the Mayor of the City of Polson, Montana, this 5th day of August, 1968.

RESOLUTION NO. 274

A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THAT CERTAIN TRACT OR PARCEL OF LAND HEREINAFTER DESCRIBED, WHICH LAND IS CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Polson, Montana on the 5th day of August, 1968, duly and regularly passed and adopted a Resolution declaring it to be to the best interest to the City of Polson, Montana, and of the inhabitants of the hereinafter described tract of land that the boundaries of the said City be extended to include within the corporate limits of the City of Polson, Montana, the said tract of land; and

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said tract of land, once a week for two (2) successive weeks, a Notice to the effect that said Resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said Notice the City Clerk would receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of said City from the resident freeholders of the territory proposed to be embraced therein; and

Whereas, the City Clerk, according to law, did forthwith notify in writing all property holders within the boundaries of the hereinafter-described tract of land; and

WHEREAS, said Resolution was published on the 8th day of August, 1968, and on the 15th day of August, 1968, and more than twenty (20) days has elapsed since the first publication of said Resolution as is evidenced by the Affidavit of Publication on file in the records of the City Clerk of the City of Polson, Montana; and

WHEREAS, the City Clerk has laid before the City Council all of the communications received by him relative to the said proposed extension of the boundaries; and

WHEREAS, it appears that no communications were in fact received within the said twenty (20) day period and the City Council, after due consideration, deems it for the best interest of said City and the inhabitants thereof and the inhabitants of the hereinafter-described contiguous tract of land that the boundaries of the City of Polson, Montana, should be extended so as to include the herein-after-described tract of land within the corporate limits thereof.
