RESOLUTION NO. 274

A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THAT CERTAIN TRACT OR PARCEL OF LAND HEREINAFTER DESCRIBED, WHICH LAND IS CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Polson, Montana on the 5th day of August, 1968, duly and regularly passed and adopted a Resolution declaring it to be to the best interest to the City of Polson, Montana, and of the inhabitants of the hereinafter described tract of land that the boundaries of the said City be extended to include within the corporate limits of the City of Polson, Montana, the said tract of land; and

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said tract of land, once a week for two (2) successive weeks, a Notice to the effect that said Resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said Notice the City Clerk would receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of said City from the resident freeholders of the territory proposed to be embraced therein; and

Whereas, the City Clerk, according to law, did forthwith notify in writing all property holders within the boundaries of the hereinafter-described tract of land; and

WHEREAS, said Resolution was published on the 8th day of August, 1968, and on the 15th day of August, 1968, and more than twenty (20) days has elapsed since the first publication of said Resolution as is evidenced by the Affidavit of Publication on file in the records of the City Clerk of the City of Polson, Montana; and

WHEREAS, the City Clerk has laid before the City Council all of the communications received by him relative to the said proposed extension of the boundaries; and

WHEREAS, it appears that no communications were in fact received within the said twenty (20) day period and the City Council, after due consideration, deems it for the best interest of said City and the inhabitants thereof and the inhabitants of the hereinafter-described contiguous tract of land that the boundaries of the City of Polson, Montana, should be extended so as to include the herein-after-described tract of land within the corporate limits thereof.

NOW, THEREFORE, BE IT RESOLVED that the boundaries of the City of Polson, Montana, shall be extended so as to include the property described as follows, to-wit:

A portion of the West 273 feet of the South 1187 feet of the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 9, Township 22 North, Range 20 West, M.P.M., County of Lake, Montana, and more Particularly described as follows:

Beginning at a point 1047 feet West of the Southeast corner of Lewis Addition to the City of Polson, Lake County, Montana, on the South Line of "K" Street, thence South 504 feet; thence West 200 feet; thence North 172 feet; thence East 180 feet; thence North 332 feet; thence East 20 feet to the point of beginning, 0.94 plus or minus acres.

This Resolution shall take effect on the 7 day of October, 1968.

The foregoing Resolution was duly and regularly passed by the City Council of the City of Polson, Montana, and adopted, and approved by the Mayor of the City of Polson, Montana, this 7 th day of October, 1968.
