

AN ORDINANCE AMENDING CHAPTER 7 OF TITLE 11 OF THE CITY CODE OF POLSON, 1965, BY AMENDING SECTION 1-7-3 THEREOF TO PROVIDE FOR THE PAYMENT OF ADDITIONAL SALARIES OF DEPARTMENT HEADS AND TO FURTHER PROVIDE FOR THE PAYMENT OF ADDITIONAL SALARIES FOR SERVICES PERFORMED DURING A PUBLIC EMERGENCY IN THE CITY OF POLSON, MONTANA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 7 of Title 1 of the City Code of Polson, 1965, shall be amended by amending Section 1-7-3 to read as follows:

1-7-3 Department Heads Salaries-Employees Wages-Overtime Pay for Services to City During Public Emergency: The salaries of all department heads for services performed during the regular course of their employment shall be Four Hundred Eighty and 00/100ths Dollars (\$480.00) per month.

The salary for the Assistant Street Superintendent for all services performed during the regular course of his employment shall be Four Hundred Twenty and 00/100ths Dollars (\$420.00) per month. In the event of a public emergency, including but not limited to snow removal and flood control, all employees of the City of Polson, including department heads, shall be entitled to receive additional compensation for work performed during such public emergencies. The hourly rate of compensation that each such employee shall receive shall be determined by dividing the annual salary by 2080, being the number of hours of regular work during one year.

REPEALING CLAUSE: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

EMERGENCY: An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.

RESOLUTION NO. 277

A RESOLUTION ORDERING THE TRANSFER OF MONIES FROM THE WATER DEPARTMENT SALARIES AND CAPITAL OUTLAY BUDGET TO THE WATER DEPARTMENT MAINTENANCE AND OPERATION BUDGET.

WHEREAS, there presently exists an impending deficit in the maintenance and operation budget of the Water Department, and;

WHEREAS, there presently exists a probable excess in the salaries and capital outlay budget of the Water Department,

NOW THEREFORE, BE IT RESOLVED by the City of Polson, Montana, as follows:

It is hereby ordered, and this does order, that the sum of Two Thousand and no/100ths Dollars (\$2,000.00) shall be transferred from the salaries budget of the City of Polson Water Department Fund to the maintenance and operation budget of the City of Polson Water Department Fund, and

It is further ordered that the sum of Five Thousand and no/100ths Dollars (\$5,000.00) be transferred from the capital outlay budget of the City of Polson Water Department Fund to the maintenance and operation budget of the City of Polson Water Department Fund.
