AN ORDINANCE AMENDING CHAPTER 2 OF TITLE 10 OF THE CITY CODE OF POLSON, 1965, BY AMENDING SECTION 10-2-14 THEREOF, MAKING IT A SPECIFIC OFFENSE TO DRIVE WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, WHILE THE OPERATORS LICENSE IS SUSPENDED OR REVOKÉD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 2 of Title 10 of the City Code of Polson, 1965, shall be amended by amending Section 10-2-14 to read as follows:

10-2-14: LICENSE REGULATIONS: The owner of a motor vehicle shall register such vehicle with the Registrar of Moto r Vehicles of the State of Montana and shall further comply with all provisions of the Motor Vehicle To plant Registration Act. The owner shall display in a conspicuous place on such registered vehicle the proper license plates which must be legible at all times for a distance of one hundred feet (100'). Any Montana resident who shall drive any motor vehicle upon the streets of the she City shall have in his possession restrivents license issued to him by the State. Non-residents shall comply in this respect with the Montana Non-Resident Act. It shall be unlawful for any Montana resident to drive or otherwise operate any motor vehicle upon the streets of the City of Polson, Montana, while his driver's license shall have been suspended or revoked by the State of Montana Highway Patrol.

REPEALING CLAUSE: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

EMERGENCY: an emergency is hereby declared to exist

and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.

NOW THEREFORE: BR IT RESOLVED that the boundary of the City of Polson, Montana, be and it hereby is extended so as to include the property described as follows, to wit:

A portion of the NE4 SW4 Section 10, T. 22N. R. 20 W. 127 M. P. M. Lake County, Montana, and more particularly described as follows:

Beginning at the SE Corner of Block 1, Hillside Addition to the City of Polson, Montana according to the official plat thereof on file in the official records of said county; thence No. Ol' E. along records of said county; thence No. Ol' E. along the east line of said Block 1, 97.3 feet to the north line of said NE4 SW4, thence along said north line S. 89 o 46' E. 153.26 feet; thence along the northerly boundary of 15th Avenue, S. 500 35' W. 152.50 feet; thence N. 890 43' W. 35.47 feet to the noint of heginging point of beginning.

RESOLUTION NO. 279

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA,

REGARDING THE PURCHASE OF

The South Half (1/2) of Lot Two (2), Lot Three (3) and
Lot Four (4), all in Block Five (5) of the original
Townsite of the City of Polson, Montana, according to the official map or plat thereof on fole and of record in the office of the Clerk and Recorder of Lake County, Montana.

WHEREAS, Sam P. Smith owner of the above-captioned real property has offered to sel the same to the City of Polson for the sum of Seventy-five Thousand and 00/100ths Dollars (\$75,000.00); and

WHEREAS, the registered electors of the City of Polson did, on the 5th day of November, 1968, authorize the City Council of the City of Polson, Montana, to purchase the said real property of Sam P. Smith for the sum of Seventy-five Thousand and 00/100ths Dollars (\$75,000.00).

NOW THEREFORE, BE IT RESOLVED by the City Council of Polson,

Montana, as follows:

That the offer of Sam P. Smith to sell the real property hereinabove described for Seventy-five Thousand and 00/100ths Dollars (\$75,000.00), be and the same hereby is accepted on the

following terms and conditions:
1. That Sam P. Smith shall have sixty (60) days from the date that said purchase price shall be tendered to vacate the

above -described premises;

2. Should it be necessary for Sam P. Smith to remain in possession of the premises for a further period of time, not to xceed an additional sixty (60) days, the said Sam P. Smith shall pay unto the City of Polson the sum of \$300.00 per month as and for rental of said property;

3. Sam P. Smith shall pay all taxes and special assessments due on a pro-rata basis at the date that said purchase price shall

be tendered to him by the City of Polson;
4. Sam P. Smith shall furnish an Abstract of Title brought to current date showing merchantable title to the above described real property vested in him; and the existing mortage on said premises shall be paid at the same time as a distribution price is made to him; and provided further that if any title defects occur, Sam P. Smith shall take prompt action to correct the same.

BE IT FURTHER RESOLVED that such steps as shall be necessary to sell bonds to raise the sum of \$ 75,000.00 shall be taken by the City Clerk and any others charged by law with the responsibility to do so.
