A RESOLUTION ORDERING THE TRANSFER OF MONIES FROM WATER REVDNUE ACCOUNT OF THE CITY OF POLSON, MONTANA, TO THE SPECIAL WATER SYSTEM IMPROVEMENT FUND OF THE CITY OF POLSON, MONTANA.

WHEREAS, the City of Polson, Montana, has established a Special Water System Improvement Account for the purpose of paying its fifty percent percent matching funds under an agreement with the Economic Development Administration concerning contracts with Tynes Construction Company, and the Liberty Drilling Company, and;
