RESOLUTION NO. 287

A RESOLUTION OF THE CITY OF POLSON, MONTANA, AUTHOR-IZING PAYMENT TO THE STATE BOARD OF EQUALIZATION, STATE OF MONTANA, OF THE SUM OF THREE HUNDRED NINETY—FOUR AND O8/100ths DOLLARS (\$394.08), SAID SUM BEING ONE PERCENT HELD BACK BY THE CITY OF POLSON FROM THE ROBERT TYNES CONSTRUCTION COMPANY, RELATIVE TO THE CONTRACT BETWEEN THE CITY OF POLSON AND SAID CONSTRUCTION COMPANY FOR THE CONSTRUCTION OF SPECIAL IMPROVEMENT SEWER-DISTRICT NO. 12.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

WHEREAS, the City of Polson entered into a Contract with the Robert Tynes Construction Company for the construction of Special Improvement Newer District Nol 12, and;

WHEREAS, the City of Polson retained one percent (1%) of said Contract for further payment to the State of Montana Board of Equalization, and;

WHEREAS, the said City inadvertently failed to pay said one percent (1%) in the amount of Three Hundred Ninety-four and 08/100ths Dollars (\$394.08) to the State of Montana Board of Equalization, and;

WHEREAS, all monies remaining in the SID 12 construction account were transferred into the City of Polson revolving fund upon the assumption that all payments owing by said Special Improvement District had been theretofore previously made, and;

WHEREAS, the City of Polson owes an obligation to the State of Montana Board of Equalization in the sum of Three Hundred Ninety-four and O8/100ths Dollars (\$394.08).

Now THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, as follows:

That the City Clerk draw a warrant bearing this resolution number, in the amount of Three Hundred Nimety-four and 08/100ths Dollars (\$394.08) payable to the State of Montana, State Board of Equalization on the revolving fund of the City of Polson, Montana.

BE IT FURTHER RESOLVED that said warrant, when so drawn and executed by the proper officers of this City, be forwarded to the State Board of Equalization for payment on account of the Robert Tynes Construction Company.
