ORDINANCE NO. 330

AN ORDINANCE PROHIBITING THE OPERATION OF SNOWMOBILES AND ALL TERRAIN VEHICLES UPON PUBLIC WAYS AND PROPERTY WITHIN THE CITY OF POLSON, PROVIDING FOR PENALTIES, REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, AND DE-CLARING THIS ORDINANCE TO BE A PUBLIC EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 2 of Title 10 of the City Code of Polson, 1965, shall be amended by adding Sub-Section (T) to Section 10-2-8 thereof, which Section shall read as follows:

10-2-8 (T): It shall be unlawful for any person to operate any snowmobile or all terrain vehicle on any of the streets, avenues, alleys, parks, golf course, or upon any other public way or property owned by the City of Polson, Montana. Conviction for violation of this Section shall be punishable for the first offense by a fine of not less than Ten and 00/100ths Dollars (10.00). All subsequent convictions shall be punishable by a fine of not less than Twenty-five and 00/100ths Dollars (\$25.00) nor more than Fifty and 00/100ths Dollars (\$50.00).

REPEALING CLAUSE: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

EMERGENCY: Apublic emergency is hereby edclared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.
