RESOLUTION NO. 309

A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THAT CERTAIN TRACT OR PARCEL OF LAND HEREINAFTER DESCRIBED, WHICH LAND IS CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Polson, Montana, on the 4th day of January, 1971, duly and regularly passed and adopted a Resolution declaring it to be to the best interest to the City of Polson, Montana, and of the inhabitants of the hereinafter described tract of land that the boundaries of the said City be extended to include within the corporate limits of the City of Polson, Montana, the said tract of land, and;

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said tract of land, once a week for tow (2) successive weeks, a notice to the effect that said Resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said Notice the City Clerk would receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of said City from the resident freehalders of the territory proposed to be embraced therein, and;

WHEREAS, the City Clerk, according to law, did forthwith notify in writing all property holders within the boundaries of the hereinafter described tract of land, and;

WHEREAS, SAID Resolution was published on the 14th day of January, 1971, and on the 21st day of January, 1971, and more than twenty (20) days have elapsed since the first publication of said Resolution as is evidenced by the Affidavit of Publication on file in the records of the City Clerk of the City of Polson, Montana, and,

WHEREAS, the City Clerk has laid before the City Council all of the communications received by him relative to the said proposed extension of the boundaries, and;

WHEREAS, it appears that no communications were in fact received within the said twenty (20) day period and the City Council, after due consideration, deems it for the best interest of said City and the inhabitants thereof and the inhabitants of the hereinafter described contiguous tract of land that the boundaries of the City of Polson, Montana, should be extended so as to include the hereinafter described tract of land within the corporate limits thereof.

NOW, THEREFORE, BE IT RESOLVED that the boundaries of the City of Polson, Montnan, shall be extended so as to include the property described as follows, to-wit:

The West Half $(W_{\overline{z}}^{1})$ of Lot Three (3) and all of Lot Four (4) of Block One (1), Hillside Addition, a platted subdivision.

This Resolution shall take effect on the 15th day of February, 1971.

The foregoing Resolution was duly and regularly passed by the City Council of the City of Polson, Montana, and adopted and approved by the Mayor of the City of Polson, Montana, this 15th day of February, 1971.
