

RESOLUTION NO. 316

A RESOLUTION CREATING AN EMERGENCY BUDGET PURSUANT TO REVISED CODES OF MONTANA, 1947, SECTION 11-1409, FOR THE POLICE FUND CALLING FOR THE TRANSFER O MONIES FROM THE BEER TAX FUND TO THE SALARIES FUND OF THE POLICE DEPARTMENT, AND PROVIDING FOR REGISTRATION OF WARRANTS DRAWN IN EXCESS OF MONIES AVAILABLE IN THE MAINTENANCE AND OPERATION FUND OF THE POLICE DEPARTMENT.

WHEREAS, a public emergency exists which could not have been reasonably foreseen at the time of making the City Budget for th City of Polson, Montana, and;

WHEREAS, the Salaries and Maintenance and Operation Fund of the Police Department has insufficient monies for current needs, and thus a public emergency exists, and;

WHEREAS, it is estimated that ~~Three~~ Three Thousand and 00/100ths Dollars (\$3,000.00) will be required to meet the emergency exist- ing in the Salaries Fund of the Police Department, and One Thous- and and 00/100ths Dollars (\$1,000.00) will be required to meet the emergency existing in the Maintenance and Operation Fund of the Police Department, and;

WHEREAS, there presently exists a ~~Three~~ Three Thousand Sixty-eight and 00/100ths Dollars (\$3,068.00) balance in the Beer Tax Fund against which Fund the Three Thousand and 00/100ths (\$3,000.00) deficit in the Salaries Fund of the Police Department shall be drawn, and whereas the One Thousand and 00/100ths Dollars (\$1,00.00) deficit in the Maintenance and Operation Fund of the Police Depart- ment shall be paid by registered warrants, and;

WHEREAS, a public hearing will be held on the creation of said emergency budget on Monday, June 28, 1971, at the hour of 8:00 P. M. at the City Hall of the City of Polson, Montana, Notice of said hearing to be published in the Flathead Courier on Thursday, June 17, 1971.

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Montana:

That a public emergency exists in that there are insufficient funds for the operation of the Salaries and Maintenance and Operation Funds of the Police Department of the City of Polson, Montana, and it is necessary to create an emergency budget in the amount of Four Thousand and 00/100ths Dollars (\$4,000.00) for the continuing operation of said Funds during the Budget year of 1971, Three Thousand and 00/100th Dollars (\$3,000.00) of said emergency warrants to be drawn against the Beer Tax Fund of the City of Polson, Montana, and One Thousand and 00/100ths Dollars (\$1,000.00) of said emergency warrants to be registered.

Be it further resolved that a public hearing will be held on the question of creating the said emergency budget at 8:00 P. M. on Monday, June 28, 1971, at the City Hall of the City of Polson, Montana.

Be it further resolved that a copy of this Resolution be publish- ed in the Flathead Courier on the 17th day of June, 1971.
