RESOLUTION NO. 324

A RESOLUTION CREATING AN EMERGENCY BUDGET PURSUANT TO REVISED CODES OF MONTANA, 1947, SECTION 11-1409, FOR THE MAINTENANCE AND OPERATION DEPARTMENT OF THE GENERAL FUND, STATING THEFFUND AGAINST WHICH THE EMERGENCY WARRANTS SHALL BE DRAWN, CALLING FOR THE TRANSFER OF MONEY FROM THE SPECIAL BUILDING FUND TO THE MAINTENANCE AND OPERATION DEPARTMENT OF THE GENERAL FUND, SPECIFYING THE FACTS CONSTITUTING THE EMERGENCY, AND PROVIDING FOR NOTICE OF PUBLIC HEARING.

WHEREAS, a public emergency exists which could not have been reasonably foreseen at the time of making the current City budget for the City of Polson, Montana, and;

WHEREAS, the Maintenance and Operation Department of the General Fund has insufficient monies for current need, and thus an emergency exists, and;

WHEREAS, it is estimated that Seven Hundred Fifty and 00/100ths Dollars (\$750.00) will be required to meet the emergency existing in the Maintenance and Operation Department of the General Fund, and;

WHEREAS, the fund against which emergency warrants shall be drawn is the Special Building Fund of the City of Polson, Montana, and;

WHEREAS, a public hearing will be held on the creation of said emergency budget on Monday, January 17, 1972, at the hour of 8:00 P. M. at the City Hall of the City of Polson, Montana, Notice of said hearing to be published in the Flathead Courier on Thursday, January 6, 1972.

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Montana:

That a public emergency exists in that bhere are insufficient funds for the operation and Maintenance and Operation Department of the General Fund of the City of Polson, Montana, and it is necessary to create an emergency budget in the amount of Seven Hundred Fifty and OO/100th Dollars (\$750.00) for the continuing operation of said Department during the budget year 1971-1972, said emergency warrants to be drawn against the Special Building Fund of the City of Polson, Montana.

Be it further resolved that a public hearing will be held on the question of creating the said emergency budget at 8:00 P. M. on Monday, January 17, 1971, at the City Hall of the City of Polson, Montana.

Be it further resolved that a copy of this Resolution, fursuant to Revised Codes of Montana, 1947, Section 11-4409, be published in the Flathead Courier on Thursday, January 6, 1972.
