

A RESOLUTION CREATING AN EMERGENCY BUDGET PURSUANT TO REVISED CODES OF MONTANA, 1947, SECTION 11-1409, FOR THE EQUIPMENT PURCHASE FUND, STATING THE FUND FROM WHICH THE MONIES SHALL BE TRANSFERRED INTO THE EQUIPMENT PURCHASE FUND, CALLING FOR THE TRANSFER OF MONEY FROM THE 1971-1972 EQUIPMENT PURCHASE FUND OF THE CITY OF POLSON TO THE 1972-1973 EQUIPMENT PURCHASE FUND, SPECIFYING THE FACTS CONSTITUTING THE EMERGENCY AND PROVIDING FOR NOTICE OF PUBLIC HEARING.

WHEREAS, a public emergency exists which could not have been reasonably foreseen at the time of making the current city budget for the City of Polson, Montana, and;

WHEREAS, the Equipment Purchase Fund has insufficient monies to meet current needs, and thus the said emergency exists, and;

WHEREAS, it is estimated that Two Thousand Four Hundred Forty-eight and 49/100ths Dollars (\$2,448.49) will be required to meet the emergency in the Equipment Purchase Fund, and;

WHEREAS, at the close of the 1971-1972 budget year there remained in the Equipment Purchase Fund the sum of Two Thousand Four Hundred Forty-eight and 49/100ths Dollars (\$2,448.49) which was not carried forward, through inadvertance, into the 1972-1973 budget although said funds remain on deposit at the Security State Bank to the credit of the City of Polson, Montana. It is therefore the purpose of this resolution to provide for the inclusion of said funds in the Equipment Purchase fund of the 1972-1973 budget of the City of Polson, Montana.

WHEREAS, a public hearing will be held on said emergency budget on Monday, April 2, 1973, at the hour of 8:00 p.m. at the City Hall of the City of Polson, Montana, with notice of said hearing to be published in the Flathead Courier on Thursday, March 15.

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Montana:

That a public emergency exists in that there are insufficient funds for the operation of the Equipment Purchase Fund of the City of Polson, Montana and it is therefore necessary to create an emergency budget in the sum of Two Thousand Four Hundred Forty-eight and 49/100ths Dollars (\$2,448.49) for the continuing operation of said Fund during the budget year of 1972-1973, said funds to be transferred from the 1971-1972 Equipment Purchase Fund of the City of Polson, Montana.

Be it further resolved that a public hearing will be held on the question of creating the said emergency budget at 8:00 p.m. on Monday, April 2, 1973, at the City Hall of the City of Polson, Montana.

Be it further resolved that a copy of said Resolution, pursuant to the Revised Codes of Montana, 1947, Section 11-1409 be published in the Flathead Courier on Thursday, March 15, 1973.
