## RESOLUTION NO. 343

A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THOSE CERTAIN TRACTS OR PARCELS OF LAND HEREINAFTER DESCRIBED, WHICH LAND IS CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Pllson, Montana, on the 1st day of April, 1974, duly and regularly passed and adopted a Resolution declaring it to be to the best interest to the City of Polson, Montana, and of the inhabitants of the hereinafter described tracts of land that the boundaries of the said City be extended to include within the corporate limits of the City of Polson, Montana, the said tracts of land; and

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said tracts of land, once a week for two (2) successive weeks, a Notice to the effect that said Resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said Notice the City Clerk would receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of said City from the resident freeholders of the territory proposed to be embraced therein; and

WHEREAS, the City Clerk, according to law, did forthwith notify in writing all property holders within the boundaries of the hereinafter described tracts of land; and

WHEREAS, said Resolution was published on the 11th day of April, 1974, and on the 18th day of April, 1974, and more than twenty (20) days has elapsed since the first publication of said Resolution as is enidenced by the Affidavits of Publication on file in the records of the City Clerk of the City of Polson, Montana; and

WHEREAS, the City Clerk has laid before the City Council all of the communications received by her relative to the said proposed extension of the boundaries; and

WHEREAS, it appears that no communications were in fact received within the said twenty (20) day period relative to the tracts of land hereinafter particularly set forth and the City Council, after due consideration, deems it for the best interest of the Gaid City and the inhabitants thereof and the inhabitants of the hereinafter described contiguous tracts of land that the boundaries of the City of Polson, Montana, should be extended so as to include the hereinafter described tracts of land within and corporate limits thereof.

NOW, THEREFORE, BE IT RESOLVED that the boundaries of the City of Polson, Montan, shall be extended so as to include the property described as follows, to-wit:

Lot 7 of Block 1 of East Hiklside Addition according to the official map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

ALSO

Lot 9 of Block 1 of East Hillside Addition according to the official map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

ALSO

Lot 10 of Block 2 of East Hillside Addition according to the official map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

This Resolution shall take effect on the 15th day of July, 1974.
