Principal and interest will be made payable at any suitable banking institution designated by the successful bidder within 48 hours after the award of sale, subject to approval by the City Council. The City will pay reasonable and customary paying agency charges. Forty days after the award of sale, and without cost to the purchaser, the City will furnish printed and executed bonds, the customary certificate as to absence of ligigation and the unqualified approving legal opinion of Messrs. Dorsey, Marquart, Windhorst, West & Halladay, of Minneapolis, Minnesota. Payment for the bonds will be made at Polson, Montana or Minneapolis, Minnesota, or elsewhere, if desired, at the expense of the purchaser.

Each bid must be undonditional, and must be accompanied by a cashier's or certified check or bank draft in an amount not less than \$15,000, payable to the City Treasurer of the City of Polson, which may be retained by the City as liquidated damages in the event that the bid is accepted and the bidder shall fail to comply therewinth. The bid offering the lowest net interest cost (total interest from the date of the bonds to the stated maturities less any cash premium) will be deemed the most favorable. No bid of less than par and accrued interest will be considered, and the City Council reserves the right to reject any and all bids, to waive any informality in any bid, and to adjourn the sale if deemed necessary.
