

## RESOLUTION NO. 366

A RESOLUTION CREATING AN EMERGENCY BUDGET PURSUANT TO REVISED CODES OF MONTANA, 1947, SECTION 11-1409, PROVIDING FOR DISTRIBUTION OF EXCESS TAX REVENUES ON A PRO-RATA BASIS TO VARIOUS FUNDS, SPECIFYING THE FACTS CONSTITUTING THE EMERGENCY AND PROVIDING FOR NOTICE OF PUBLIC HEARING.

WHEREAS, a public emergency exists which could not have been reasonably foreseen at the time of making the current city budget for the City of Polson, Montana, and;

WHEREAS, there now exists an excess of tax revenues to the credit of the City of Polson, and;

WHEREAS, it is the purpose of this resolution to distribute the excess tax revenues on a pro-rata basis, according to mill levies, to various funds of the City of Polson, and;

WHEREAS, a public hearing will be held on said emergency budget on Monday, February 16, 1976, at the hour of 8:00 p.m. at the City Hall of the City of Polson, Montana, with notice of said hearing to be published in the Flathead Courier on the 5th day of February, 1976.

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Montana:

That a public emergency exists in that there are excess tax revenues in the sum of Nineteen Thousand Dollars (\$19,000.00) now held by the City of Polson and it is therefore necessary to create an emergency budget to allocate said revenues. The said revenues shall be deposited in the following amounts in the designated funds:

General Fund (26 mills)	\$7,967.80
Street Fund (14 mills)	\$4,290.30
Park Fund (8 mills)	\$2,451.60
Sewer Fund (4-1/2 mills)	\$1,379.03
Fire Disability Fund (1 mill)	\$ 306.45
Library Fund (4-1/2 mills)	\$1,379.02
Airport Fund (1 mill)	\$ 306.45
Building Bonds & Interest Fund (3 mills)	\$ 919.35

Be it further resolved that a public hearing will be held on the question of creating the said emergency budget at 8:00 p.m. on Monday, February 16, 1976, at the City Hall of the City of Polson, Montana.

Be it further resolved that a copy of said Resolution, pursuant to the Revised Codes of Montana, 1947, Section 11-1409, be published in the Flathead Courier on Thursday, February 5, 1976.
