

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, TO CREATE A SPECIAL IMPROVEMENT DISTRICT IN THE CITY OF POLSON, MONTANA, FOR THE PURPOSE OF THE EXCAVATION AND REMOVAL OF OLD SIDEWALK, PEREPRATION OF SURFACE, PLACEMENT OF NEW CURB AND GUTTER, PLACEMENT OF NEW SIDEWALK, BACKSLOPING OF LOTS 3, 4, 5, 6, AND APPLICATION OF HOT-MIX ASPHALT ON THE SOUTH SIDE OF FIFTH AVENUE FROM ITS INTERSECTION WITH MAIN STREET ON THE WEST CONTINUING, THENCE IN AN EASTERLY DIRECTION TO THE INTERSECTION OF FIFTH AVENUE WITH FIRST AVENUE EAST, DESCRIBING THE BOUNDARIES THEREOF, STATING THE GENERAL NATURE AND CHARACTER OF THE PROPOSED IMPROVEMENTS, DESIGNATING THE NUMBER OF SAID DISTRICT, STATING THE APPROXIMATE COST OF SAID IMPROVEMENTS, PROVIDING FOR THE GIVING OF NOTICE OF THE TIME AND PLACE FOR THE HEARING OF PROTESTS AGAINST THE PROPOSED DISTRICT, THE WORK, OR AGAINST THE CREATION OF SAID DISTRICT, OR THE EXTENT THEREOF, OR BOTH.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, LAKE COUNTY:

SECTION 1. That the public convenience and safety requires, and it is deemed necessary to order, establish and create, and the City Council of the City of Polson, Montana, does hereby declare its intention to create a Special Improvement Paving District within the City of Polson, Montana, the boundary of which is hereafter particularly described.

SECTION 2. That this Special Improvement District shall be known and designated as Special Improvement Paving District No. 23.

SECTION 3. That the subject of this Special Improvement District and the land t which the excavation and removal of old sidewalk, preparation of surface, placement of new curb and gutter, placement of new sidewalk, backsloping of lots 3, 4, 5, 6, and application of hot-mix asphalt shall be applied is located in the City of Polson, Montana, and is particularly described as follows, to-wit:

The South side of Fifth Avenue from its intersection with Main Street on the West continuing, thence in an easterly direction to the intersection of Fifth Avenue with First Avenue East.

SECTION 4. That the property included within, and the boundary of said Special Improvement District is determined by the inclusion of the following described l ts located in the City of Polson, and particularly described as follows, to-wit:

Lot One (1), Block Twenty-four (24)  
 Lot Two (2), Block Twenty-four (24)  
 Lot Three (3), Block Twenty-four (24)  
 Lot Four (4), Block Twenty-four (24)  
 Lot Five (5), and Lot Six (6), Block Twenty-four (24)

all of said lots and blocks are located in Polson Original Townside according to th official mat or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

SECTION 5. That the district included within said boundary and the area dâscribed therein is hereby declared to be the district and property benefited by said improvement and the real estate and premises therein described, and therein included is hereby declared to be the property to be assessed for the costs and expenses of making such improvements.

SECTION 6. The general nature and character of the proposed improvement to be made in said district is the excavation and removal of old sidewalk, preparation f surface, placement of new curb and gutter, placement of new sidewalk, backsloping of lots 3, 4, 5, 6, and application of hot-mix asphalt laid in place by Barber Green, or comparable equipment, on the South side of Fifth Avenue from its intersection with Main Street on the West continuing, thence in an easterly direction to th intersection of Fifth Avenue with First Avenue East.

SECTION 7. That the estimatec cost, including all engineering fees is approximately Five Thousand Nine Hundred Ten and 20/100th Dollars (\$5,910.20), which sum is approximately 19.07 dollars per lineal foot of each lot fronting on that portion of Fifth Avenue, as hereinabove more particulary described, which is included in said Special Improvement District, with payment thereof to be spread over a period of ten (10) Years.

SECTION 8. That upon passage and approval of this Resolution, the City Clerk of the City of Polson, Montana, is hereby directed to give Notice, by publication and by mailing, as provided by Section 11-2294 of the Revised Codes of Montana, 1947
