RESOLUTION OF INTENTION TO EXTEND THE BOUNDARIES OF THE CITY OF POLSON, MONTANA, AND TO INCLUDE THOSE CERTAIN TRACTS OR PARCELS OF LAND HEREINAFTER DESCRIBED WHICH ARE CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

Askelson, Stanley C. Young, Donald W. Young, Kathleen K. Young, Charles D. Olson, Charlene L. Olson, Fred A. Plummer, Kathryn D. Plummer, William R. Ingram, Jolanda A. Ingram, 4B's Restaurants, Inc., a Corprati n, John W. Schutt, and Carol M. Schutt, owners of tracts of land contiguous to th City of Polson, Lake County, Montana have requested that the City of P 1s next nd its boundaries so as to include the following described tracts of land within the corporate limits of the City of Polson, Lake County, Montana; and

WHEREAS, the City Council of the City of Polson at a regular meeting held on the 21st day of May, 1979, at the City Hall in the City of Polson, Montana, duly c nsidered the question of extending the boundaries of the City of Polson to include the contiguous tracts of land hereinafter described; and

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Lak C unty, Montana, that it is their intention to extend the boundaries of the City of Polson, Montana, so as to include the above-described contiguous tracts of land within the corporate limits thereof, and

BE IT FURTHER RESOLVED, that in the judgment of the City Council of the City of P lson, Montana, it will be to the best interests of the City and the inhabitants thereof, and in the best interests of the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the City of Polson, Montana.

BE IT FURTHER RESOLVED, that the City Clerk of the City of Polson, Montana, forthwith notify in writing all property holders within the boundaries of the hereinbefore described tracts of land, and cause to be published in the Flathead Courier, a newspaper published in the City of Polson once a week for two successiv weeks, a notice of the passage of this resolution which notice shall further state that for a period of twenty days after the publication thereof, the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of the City of Polson, Montana, as in this resolution provided, from free holders of the territory herein proposed to be embraced in the corporate limits of the City of Polson, Montana.

The foregoing resolution was duly and regularly passed by the City Council f Polson, Montana, and adopted and approved by the Mayor of the City of Polson this 21st day of May, 1979.
