

RESOLUTION NO. 412

A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THOSE CERTAIN TRACTS OR PARCELS OF LAND HEREINAFTER DESCRIBED, WHICH LAND IS CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Polson, Montana, on the 19th day of January, 1981, duly and regularly passed and adopted a resolution declaring it to be to the best interest of the City of Polson, Montana, and of the inhabitants of the hereinafter described tracts of land that the boundaries of the said City be extended to include within the corporate limits of the City of Polson, Montana, the said tract of land; and

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said tract of land, once a week for two (2) successive weeks, a notice to the effect that said resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said notice the City Clerk would receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of said City from the resident freeholders of the territory proposed to be embraced therein; and

WHEREAS, the City Clerk, according to law, did forthwith notify in writing all property holders within the boundaries of the hereinafter described tracts of land; and

WHEREAS, said resolution was published on the 5th day of February, 1981, and on the 12th day of February, 1981, and more than twenty (20) days has elapsed since the first publication of said resolution as is evidenced by the Affidavit of Publication on file in the records of the City Clerk of the City of Polson, Montana; and

WHEREAS, the City Clerk has laid before the City Council all of the communications received by her relative to the said proposed extension of the boundaries; and

WHEREAS, it appears that no communications were in fact received within the said twenty (20) day period and the City Council, after due consideration, deems it for the best interest of said City and the inhabitants of the hereinafter described contiguous tract of land that the boundaries of the City of Polson, Montana, should be extended so as to include the hereinafter described tract of land within the corporate limits thereof; and

WHEREAS, the owners of said tract of land have agreed to assume the obligation for payment of the current annual assessments of SID #14 of the City of Polson and have agreed to pay a lump sum payment for their pro-rated share of past assessments of SID #14.

NOW, THEREFORE, BE IT RESOLVED that the boundaries of the City of Polson, Montana, shall be extended so as to include the property described as follows, to-wit:

Lot 19 of Seifert Tract and Lot A of Suzanne Addition, according to the official map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

BE IT FURTHER RESOLVED that the owners of said tract of land shall be responsible for payment of the current annual assessments of SID #14 of the City of Polson in the amount of Forty-Three and 28/100ths Dollars (\$43.28), and for payment of a lump sum payment for their pro-rated share of past assessments of SID #14 of the City of Polson in the amount of Three Hundred Eighty Nine and 52/100ths Dollars (\$389.52). This resolution shall take effect on the 16th day of March, 1981.

The foregoing Resolution was duly and regularly passed by the City Council of the City of Polson, Montana, and adopted and approved by the Mayor of the City of Polson, Montana, this 16th day of March, 1981.
