

## RESOLUTION NO. 458

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, TO CREATE A SPECIAL IMPROVEMENT DISTRICT IN THE CITY OF POLSON, MONTANA, FOR THE PURPOSE OF THE PREPARATION OF SURFACE, PLACEMENT OF NEW CURB AND GUTTER, AND APPLICATION OF HOT-MIX ASPHALT ON THE MAIN STREET FROM ITS INTERSECTION WITH 7TH AVENUE ON THE NORTH CONTINUING THENCE IN A SOUTHERN DIRECTION TO THE INTERSECTION OF 8TH AVENUE DESCRIBING THE BOUNDARIES THEREOF, STATING THE GENERAL NATURE AND CHARACTER OF THE PROPOSED IMPROVEMENTS, DESIGNATING THE NUMBER OF SAID DISTRICT, STATING THE APPROXIMATE COST OF SAID IMPROVEMENTS, PROVIDING FOR THE GIVING OF NOTICE OF THE TIME AND PLACE FOR THE HEARING OF PROTESTS AGAINST THE PROPOSED DISTRICT, THE WORK, OR AGAINST THE CREATION OF SAID DISTRICT, OR THE EXTENT THEREOF, OR BOTH.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, LAKE COUNTY:

SECTION 1. That the public convenience and safety requires, and it is deemed necessary to order, establish and create, and the City Council of the City of Polson, Montana, does hereby declare its intention to create a Special Improvement Paving District within the City of Polson, Montana, the boundary of which is hereafter particularly described.

SECTION 2. That this Special Improvement District shall be known and designated as Special Improvement Paving District No. 28.

SECTION 3. That the subject of this Special Improvement District and the land to which the removal of existing curbing, preparation of surface, placement of new curb and gutter, hot mix asphalt shall be applied is located in the City of Polson, Montana, and is particularly described as follows, to-wit:

East and west side of main street from its intersection with 7th avenue on the north continuing, thence in a southern direction to the intersection of eighth avenue.

SECTION 4. That the property included within, and the boundary of said Special Improvement District is determined by the inclusion of the following described lots located in the City of Polson, and particularly described as follows, to-wit:

Lots one (1) and twelve (12), Block one (1), Central Addition and lots five (5), five B (5B), and six B (6B) of Cline Block. All of said lots are located in Polson Townsite according to the official map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

SECTION 5. That the district included within said boundary and the area described therein is hereby declared to be the district and the property benefiting by said improvement and the real estate and premises therein described, and therein included is hereby declared to be the property to be assessed for the costs and expenses of making such improvements.

SECTION 6. The general nature and character of the proposed improvements to be made in said district is the preparation of surface, placement of new curb and gutter, and application of hot-mix asphalt laid in place on Main Street from its intersection with 7th avenue on the north continuing, thence in a southern direction to the intersection of eighth avenue on the south.

SECTION 7. The estimated cost, including all engineering fees, is approximately Four thousand four hundred eighty dollars (\$4,480.00), which sum is approximately eight dollars per lineal foot of each lot fronting on that portion of main street, as hereinabove more particularly described, which is included in said Special Improvement District, with payment hereof to be spread over a period of ten (10) years.

SECTION 8. That upon passage and approval of this Resolution, the City Clerk of the City of Polson, Montana, is hereby directed to give Notice, by publication and by mailing, as provided by Section 7-12-4105 of the Revised Codes of Montana, 1947.
