A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THOSE CERTAIN TRACTS OF LAND HEREINAFTER DESCRIBED.

WHEREAS, Irving E. Siler and Bertha M.
