

RESOLUTION 518

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POLSON, STATE OF MONTANA, AMENDING THE DESCRIPTION OF THE WARD BOUNDARIES AND CERTIFYING SUCH CHANGE IN DESCRIPTION TO THE COUNTY CLERK AND RECORDER OF LAKE COUNTY, MONTANA.

WHEREAS, the City Council of the City of Polson, State of Montana, in order to equalize the number of electors in each Ward, wished to redefine the ward boundaries of the City of Polson; and


WHEREAS, State Law requires the City to certify to the County Clerk and Recorder any alteration in the boundaries of the several Wards of the City,


See Exhibit "A" attached hereto and by this reference made a part hereof as though set forth fully at this place.

WARD I

Portions of Sections 4 and 9, Township 22 North, Range 20 West, M.P.M., Lake County, Montana.

Beginning at a "point" located on the section line between sections 4 and 9, (on 7th Avenue) which said "point" bears N. 89° 48' W-653.5 feet from section corner common to sections 3, 4, 9 and 10 T.22 N, R 20 W; thence continuing N. 89° 48' W-720.0 feet along said section line on 7th Ave., to the street intersection of 7th Ave. and 1st St. East; Thence south 1385.8 feet, along the center line of 1st St. East to the centerline intersection of 1st St. East and 11th Avenue; thence along the centerline of 11th Avenue N. 89° 48' W-2482.8 feet to the west boundary line of 6th Street West, which is presently the westerly city limit boundaries; thence north 1422.5 feet, along the west boundary of 6th Street West to the intersection of 7th Avenue (the intersection being the northwest corner of NE-1/4 NW-1/4 Sec. 9, T. 22 N., R.20 W.), thence N. 89° 48' W-272.0 feet, along the centerline of 7th Avenue; thence North 460.0 feet (plus or minus) to the southshore line of Flathead Lake; thence in a northeasterly direction along the south shoreline of said Flathead Lake 4030.0 feet (plus or minus) to the present City of Polson Boat Dock area; thence southeasterly along the south shoreline of said Flathead Lake 1946.8 feet (plus or minus) to a point, where the centerline of 5th St. East intersects the south shore of Flathead Lake; thence S. 0° 03' E, 630 feet; along the centerline of 5th Street East to the intersection of the south boundary of 4th Ave. and 5th Street East; thence West 624.2 feet along the south boundary line of 4th Avenue; thence south 1100.0 feet to the "point" of beginning on 7th Avenue.
