RESOLUTION NO. 523

A RESOLUTION OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, CREATING A SPECIAL IMPROVEMENT DISTRICT IN THE CITY OF POLSON, MONTANA FOR THE PURPOSE OF PLACEMENT OF CURB AND GUTTER ALONG THE NORTH AND SOUTH BOUNDARIES OF DIVISION STREET BETWEEN FIRST STREET EAST AND SECOND STREET EAST.

WHEREAS, the City Council of the City of Polson, Montana on the 7th day of November, 1988 passed Resolution No. 509 declaring it to be the intention of the City of Polson to create a Special Improvement District for the purpose of placement of curb and gutter along the following described boundaries:

North and South side of Division Street from the intersections with Street East in the West continuing thence in an easterly direction to the intersection of Second Street East.

WHEREAS, in accordance with the Resolution of Intent No. 509, a hearing was held on December 5, 1989 to hear objections and protests, both written and oral, to the creating of a Special Improvement District as provided by MCA 7-12-4112.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON:

That the public interest requires, and it is deemed necessary, to order, establish, and create, and the City Council of the City of Polson, Montana, does hereby create a Special Improvement District for curb and gutter within the City of Polson, Montana, the boundary of which is more particularly described above.

That this Special Improvement District shall be known and described as Special Improvement District No. 30 for curb and gutter.

That the subject of the Special Improvement District and land served by the curb and gutter district is located within the City of Polson, Montana as particularly described as follows, to-wit:

North and South sides of Division Street from its intersection with First Street East on the west continuing thence in an easterly direction to the intersection of Second Street East.

That the property included within, and the boundary of said Special Improvement District is determined by the inclusion of the following described properties located in the City of Polson, and particularly described as follows, to-wit:

Lots one (1) through twelve (12), Block 4, Center Addition, a portion of NE 1/4 NE 1/4, Section 9, Township 22 North, Range 20 West, (railroad right-of-way), located in the City of Polson.

That the district included within said boundary and the area described therein is hereby declared to be the district and the property benefited by said improvement and real estate and premises therein described, and therein included is hereby declared to be the property to be assessed for the costs and expenses of making such improvements.

The general nature and character of the proposed improvements to be made to said district is placement of curb and gutter in the area described above.

The estimated cost, including engineering fees, is approximately six thousand dollars (\$6,000.00) which sum is included in approximately ten dollars (\$10.00) per lineal foot of property fronting on that portion of the district hereinabove more particularly described, which is included in Special Improvement District, with payment thereof to be spread over a period of up to ten (10) years.

The foregoing Resolution shall take effect on the 7th day of August, 1989. PASSED AND APPROVED this 7th day of August, 1989.
