

RESOLUTION NO. 687

A RESOLUTION REGARDING MAINTENANCE OF J.B. DRIVE, WHICH STREET IS WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, PURSUANT TO AGREEMENT DATED THE 6th DAY OF September, 1993.

WHEREAS the CITY COUNCIL OF THE CITY OF POLSON, MONTANA, at a regular meeting held on the 6th day of September, 1993, at City Hall in the City of Polson, Montana duly considered the issue of maintenance of J.B. DRIVE, a public street located within the city limits of the City of Polson, Montana;

AND WHEREAS, at said City County meeting, an agreement was made between the City of Polson and MR. WILL MAVIS, owner of property fronting said J.B. DRIVE;

AND WHEREAS, the CITY COUNCIL OF THE CITY OF POLSON, MONTANA again considered the above described matter at a regular City Council meeting held on February 20, 1996 and determined that it would be in the best interests of the public and the people buying property fronting J.B. DRIVE to reduce the agreement between the City and MR. WILL MAVIS as above referenced into RESOLUTION NO. 687 and place the same of public record.

NOW THEREFORE, be it resolved by the CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, that pursuant to the agreement made and entered into by and between the City of Polson and MR. WILL MAVIS on the 6th day of September, 1993 that unless or until J.B. DRIVE is paved to a 33 foot paved surface, MR. WILL MAVIS, and any subsequent property owner fronting said J.B. DRIVE, will be responsible for the maintenance of J.B. DRIVE including snow removal, grading and other needed maintenance.

The foregoing Resolution was duly and regularly passed by the City of Council of Polson, Montana and adopted and approved by the Mayor of the City of Polson on this 20th day of February, 1996.
