WHEREAS, in response thereto, the City has published a notice of said petition in the October 23, 1997, publication of the Lake County Leader, in compliance with MCA 7-14-4114. Which notice stated, that comments will be heard and action will be taken on said petition, at the next regularly scheduled meeting of the City Council on November 3, , 1997, at 7:30 p.m. in the City Hall Council Chambers, Polson, Montana; and

WHEREAS, at the regularly scheduled meeting on November 3, 1997, the Polson City Council voted to abandon the above described.

NOW, THEREFORE, it is hereby resolved upon a majority vote of the Polson City Council as follows:

- 1. That portion of the subject cul-de-sac located on Bayview Drive, as is more particularly depicted and described on Exhibit "A" attached hereto, is vacated;
- The property vacated shall become incorporated in and attached to Applicants property described as Lot 2. 1 Slack Point III, according to the plat thereof, records of Lake County, Montana.
- Applicant shall cause to be created and recorded an Amended Plat of said Lot 1, Slack Point III, records 3. of Lake County, Montana, incorporating within the exterior boundary of said Lot 1 the vacated parcel above described;
- 4. Applicant shall grant and place of record an easement over, across, upon and through said vacated parcel to Polson School District #23 for purposes of providing a school bus turnaround; and
- 5. Unless Applicant shall fulfill the requirement of Paragraphs 3 and 4 above, within a reasonable time, this Resolution may be revoked by the City of Polson.


