

RESOLUTION REQUESTING REFERENDUM

WHEREAS, the Legislative Assembly of the State of Montana enacted Title 59, Chapter 11, of the Revised Codes of Montana 1947, and the same has been approved by the Governor of the State of Montana, and

WHEREAS, said Chapter 11 provides enabling legislation under which Firefighters may have the opportunity to vote by referendum on the question whether they desire Social Security Coverage in addition to their present coverage under the Public Employees Retirement System of the various Cities or Towns of Montana, and

WHEREAS, Chapter 11 provides that the Firefighters of Montana shall for Social Security Purposes be deemed to constitute a separate retirement system with respect to each political subdivision having positions covered thereby, and

WHEREAS, the Mayor & City Council of the City of Polson  
(Governing Body) (City or Town)

State of Montana, is the governing body of said City or Town which has Firefighter positions covered by the Public Employees Retirement System, and

NOW THEREFORE, BE IT RESOLVED that the Mayor and City Council  
(Governing Body)

of the City of Polson, State of Montana, in meeting regularly and duly assembled in the City of Polson, does hereby request that the Governor of the State of Montana authorize a referendum among the eligible Firefighters of the City of Polson, state of Montana, on the questions whether service in firefighter positions under the jurisdiction of said City of Polson and now covered by the Public Employees Retirement System of Montana shall be included or excluded under Federal Social Security as provided for under the provisions of Chapter 11 of the Revised Codes of Montana 1947.

BE IT FURTHER RESOLVED, that said Mayor and City Council does hereby  
(Governing Body)  
request that the Governor of the State of Montana promulgate and issue such authorization for a referendum on March 30, 2001 (Date for authorization should be at least ninety days prior to referendum date), and

BE IT FURTHER RESOLVED, that a copy of this Resolution, duly and properly certified, be transmitted to the Honorable Marc Racicot, Governor of the State of Montana.
