A RESOLUTION OF ANNEXATION

WHEREAS, the City of Polson has received a Petition for Annexation from Linda M. Campbell Revocable Trust, Linda M. Campbell and Bruce B. Campbell, Trustees, pursuant to M.C.A. Section 7-2-4601; and


WHEREAS, the City of Polson finds that the Petition is signed by the owner of the territory to be annexed, which property is adjacent to the existing corporate boundary of the City of Polson, said property being described as follows, to-wit:

Tract 7 and all that portion of tract 8 which lies South and East of the Northern Pacific Railway right-of-way, all in "Boettcher Tracts," Lake County, Montana, as shown by the recorded map or plat thereof, as on file and of record in the office of the Clerk and Recorder of Lake County, Montana; EXCEPTING THEREFROM that portion of Tract 8 as conveyed to Arnold P. Amundson and Isabelle M. Amundson, recorded August 5, 1974, Microfile # 218150, containing 1.43 acres more or less. FURTHER EXCEPTING THEREFROM Lot 1 of Amended Plat of Boettcher Tracts -- (Tract 7 and a portion of Tract 8, Boettcher Tracts) according to the map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana, hereto conveyed to Ray Parsons and Ebba Parsons, recorded July 28, 1977, Microfile #235718.



The property is to be zoned MRZD, and shall be in Voting Ward 2. The Clerk is directed to prepare a certified copy of this Resolution and file same in the office of the Clerk and Recorder of Lake County.


