

RESOLUTION NO. 836

A RESOLUTION TO VACATE AND ABOLISH DISTRICT 23PA ON THE TAX ROLL BOOKS AND INCLUDE ALL REAL PROPERTY THEREIN WITHIN DISTRICT 23P.

WHEREAS, the City of Polson adopted the following Resolutions:

WHEREAS, the foregoing Resolutions identified certain parcels of real property set forth therein and by this reference included here as if fully set forth herein, and such parcels were, by consequence of such Resolution, brought within the corporate limits of the City of Polson under the certain terms and conditions stated in each such resolution; and,

WHEREAS, the real property described in the foregoing Resolutions have since the time of inclusion within the corporate limits of the City of Polson been described as tax district 23PA; and,

WHEREAS, since the passage of the above-referenced Resolutions the City of Polson has extended municipal water and sewer services to the real properties described on Exhibit A hereto, and therefore the reasons underlying the separate taxing treatment of those certain real properties has ceased to exist, and tax district 23PA should be vacated and abolished, and those properties should now be included within the boundaries of tax district 23P.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, LAKE COUNTY:

SECTION 1. That tax district 23PA is hereby vacated and abolished.

SECTION 2: That tax district 23P should be amended to include those certain real properties set forth in the above-referenced Resolutions and be in future taxed, assessed, and collected in like manner as the remainder of tax district 23P.

SECTION 3: That those certain real properties described in the above-referenced Resolutions shall be removed from the rolls of the Polson Rural Fire District.
